WAIVER OF LIABILITY AND HOLD HARMLESS AGREEMENT

1. In consideration for receiving permission to rent property from Fort Detrick Outdoor Recreation Equipment Checkout Center. I hereby RELEASE, WAIVE, DISCHARGE AND COVENANT NOT TO SUE The United States Army, their officers, agents, servants, or employees (hereinafter referred to as RELEASEES) from any and all liability, claims, demands, actions and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me, or any of the property belonging to me, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES, or otherwise, while renting said property, or while in, on or upon the premises where the rental property is being utilized.

2. I am fully aware of the unusual risks involved and hazards connected with the following activities: Outdoor Recreation rental property, I hereby elect to voluntarily participate in said activities with full knowledge that said activity may be hazardous to me and my property. I VOLUNTARILY ASSUME FULL RESPONSIBILITY FOR ANY RISKS OF LOSS, PROPERTY DAMAGE OR PERSONAL INJURY, INCLUDING DEATH that may be sustained by me, or any loss or damage to property owned by me, as a result of being engaged with said property, WHETHER CAUSED BY THE NEGLIGENCE OF RELEASEES OR OTHERWISE.

3. I further hereby AGREE TO INDEMNIFY AND HOLD HARMLESS the RELEASEES from any loss, liability, damage or costs, including court costs and attorney fees, that they may incur due to my participation with the rental property, WHETHER CAUSED BY NEGLIGENCE OF RELEASEES or otherwise. Furthermore, I acknowledge that any injury incurred while participating with the rental property is not considered in the scope of employment and is therefore possibly not covered under the Federal Employees Compensation Act and the Longshoreman's and Harbor Workers Compensation Act.

4. I understand that the US Army does not maintain any insurance policy, covering any circumstance arising from my participation with the rental property or any activity associated with or facilitating that participation. As such, I am aware that I should review my personal insurance portfolio.

5. It is my express intent that this Waiver of Liability and Hold Harmless Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a RELEASE, WAIVER, DISCHARGE AND COVENANT NOT TO USE the above-named RELEASEES. I hereby further agree that this Waiver of Liability and Hold Harmless Agreement shall be construed in accordance with the laws of the State of Maryland.

6. IN SIGNING THIS RELEASE, I ACKNOWLEDGE AND REPRESENT THAT I have read the foregoing Waiver of Liability and Hold Harmless Agreement, understand it and sign it voluntarily as my own free act and deed; no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made; I am at least eighteen (18) years of age and fully competent; and I execute this Release for full, adequate and complete consideration fully intending to be bound by same.

Renter assumes full responsibility for rental equipment and all components. Renter is held liable for personal injury, death, property loss or damage. In the instance that damage occurs while equipment is in the renter's possession, repairs are not authorized unless approved by management.

Renter's POV must have adequate tow equipment with components and electric brakes installed if applicable. Equipment will not leave ECC if any or all required hook-up components (brakes, lights etc.) are missing or inoperable.

Renter is responsible for loading/unloading rental equipment in and out of POV. MWR is not responsible for the transportation, loading, or unloading of any equipment received. All logistical arrangements are the sole responsibility of the renter. Renter is responsible to supply tie-down straps and secure equipment.
